



## CALL FOR APPLICTION FOR THE RECUIRMENT OF NON-KEY EXPERTS

The EU funded project "Support to Public Administration Reform under the PAR Sector Reform Contract" is opening a second **Call for Application** for the creation of a pool of experts for the employment of short-term expertise during the course of project implementation.

#### Project context:

The **overall objective of the programme** is to strengthen the institutional and human resource capacities of the public administration and thereby improve efficiency, accountability and transparency and the quality of service delivery.

The **purpose** of the contract is to strengthen capacity of the central government to manage the comprehensive public administration reform and coordination of implementation of the PAR Sector Reform Contract through four main components:

Component	Result
Component 1: Support to Policy Making and Implementation Process	Evidence-based public policy development and coordination (covering policy planning, analysis, formulation, adoption, coordination, implementation, monitoring and evaluation) embedded in the national system through formulation and elaboration of practical tools and processes for implementation of the Law on Planning System and accompanying regulations.
Component 2: Capacity Building	Principle beneficiaries (PPS and MPALSG) and line Ministries equipped with policy development and coordination (covering planning, analysis, formulation, coordination, implementation, monitoring, evaluation and reporting) skills covering technical, analytical and other soft skills required through tailor made capacity building, mentoring and training programmes based on the policy planning system legislative framework
Component 3: Support for Further Development of the PAR Strategic Framework	General strategic framework for implementation and monitoring of the public administration reform and its underlying sub-strategies for enhancement of public policy management and regulatory reform and e-government strengthened and further developed
Component 4: Support to the Implementation of the PAR Sector Reform Contract	PAR management capacities strengthened, as well as tools and systems for effective management and donor coordination further developed, including more effective planning and implementation of the EU PAR sector reform support

The Contract has been awarded by the European Union, represented by the Delegation of the European Union to Serbia (Contracting Authority of the Project), on behalf of and for the account of Serbia as beneficiary country to the consortium led by GOPA Consultants with its partners B&S Europe, PricewaterhouseCoopers EU Services and Belit d.o.o.

Implementation started in March 2018 and will last until November 2023.

#### **Selection process**

Based on an assessment of candidates' CVs, experts with relevant experience will be shortlisted and included in a 'pool of experts'. The shortlisted candidates will be contacted in the course of project implementation, as need arises. A panel will select experts for a specific assignment based on a thorough evaluation of shortlisted candidates' relevant experience throughout project implementation. Only selected candidates will be contacted.

Experts must be independent and free from conflicts of interest within the activities to be performed, as elaborated in specific Terms of Reference (ToR).

Civil servants/public officials and other staff of the public administration of the Beneficiary country cannot be recruited as experts.

Applications not responding to above mentioned minimum requirements / criteria cannot not be taken into consideration.

In case a candidate is selected for a specific assignment, electronic copies of all relevant diplomas and work certificates need to be provided as accompanying evidence of the candidate's CV and proof of relevant work experience.
